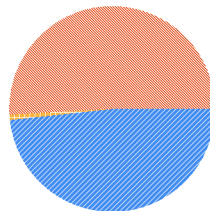

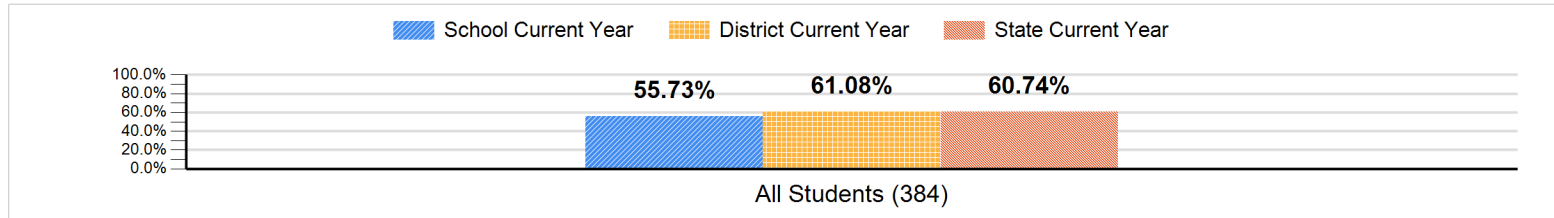
Student Population

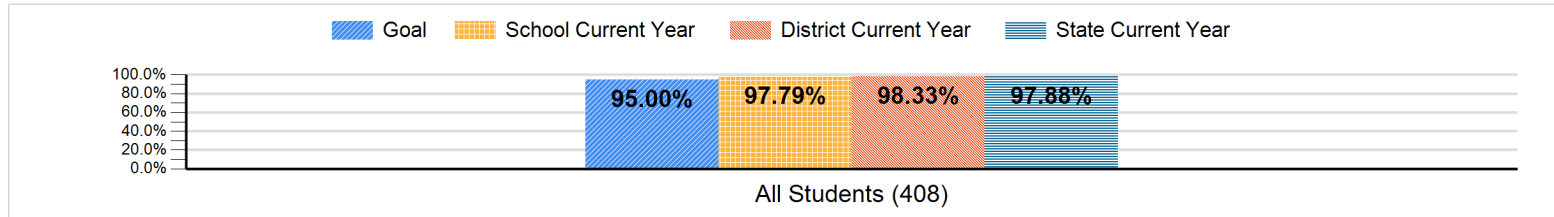

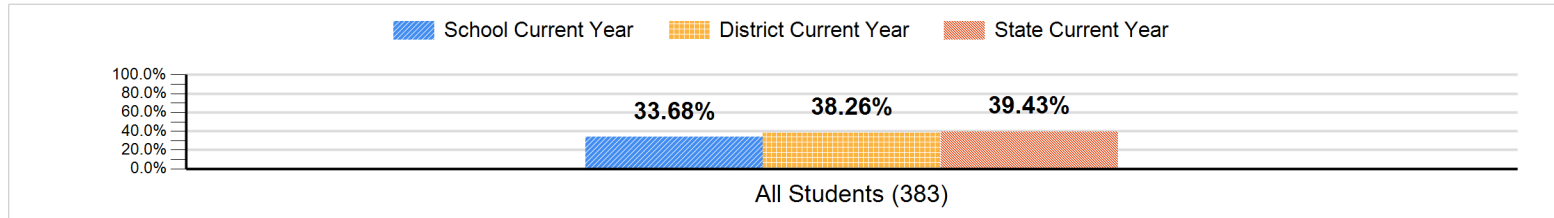

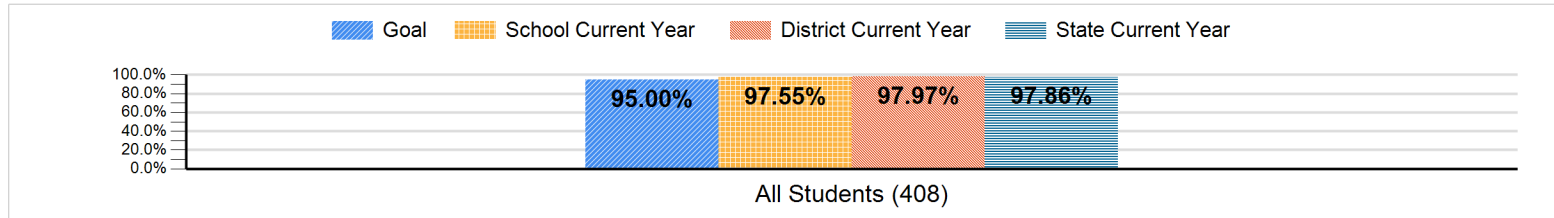

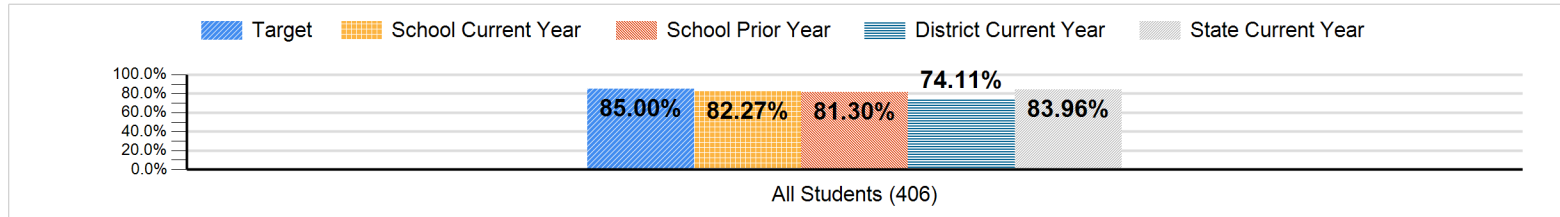

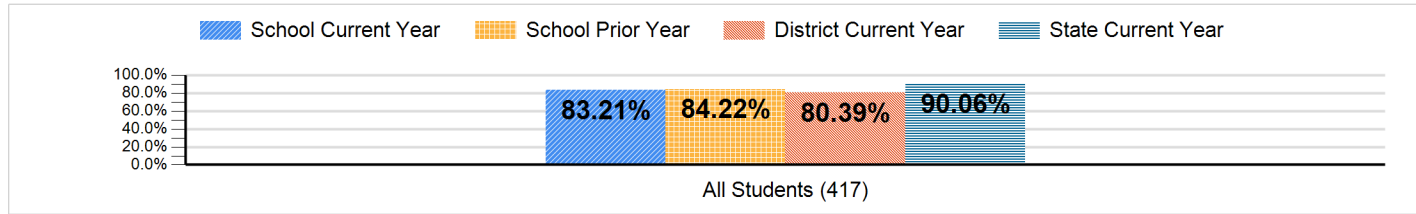
